

WELLINGTON.—9th January last, on **military warrant** for failing to proceed to camp, **Frederick George Walker**, age about twenty-eight, height 5 ft. 6 in., hotel porter, native of England, medium build, dark complexion, brown hair, blue eyes. If arrested, he is to be handed to the military authorities.

WELLINGTON.—21st December last, on **military warrant** for failing to parade for medical examination, **Frederick Victor Westbrook**, age twenty-five, height about 5 ft. 9 in., farm labourer, native of New Zealand, medium build, dark hair and complexion, grey eyes; usually dressed in a dark suit and brown-felt hat. A **provisional warrant** was issued at Auckland on the 6th February last with a view to his extradition to United States of America. Description: Grain-dealer, age thirty-six, height about 5 ft. 10 in., fair complexion, blue eyes, light-brown hair, clean-shaved but may grow beard; dresses plainly but neatly; erect carriage; dark birth-mark about size of a shilling on one knee. Accompanied by his wife, **Edith Cameron**, who is tall and dark, and has the appearance of an actress; also four children, Arthur (twelve years) Allan (ten years) Eileen (five years) and Joyce (three years). All speak with strong American accent. The elder children may be attending one of the public schools. Offender was in Christchurch under name of **Allan Cameron**, and left there with his wife and family on the 14th February last. He is in possession of an American or Canadian passport, and will probably attempt to leave New Zealand. (P. 17/378.)

### EXTRACTS FROM NEW ZEALAND GAZETTE.

*Amending Notice under Animals Protection Act.—Auckland Acclimatization District.*

LIVERPOOL, Governor.

WHEREAS it is expedient to amend, in manner herein-after provided, the notification made under the Animals Protection Act, 1908, dated the thirtieth day of March, one thousand nine hundred and seventeen, and published in the *New Zealand Gazette* of the fourth day of April, declaring a shooting season for imported and native game in the Auckland Acclimatization District:

Now, therefore, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor of the Dominion of New Zealand, do hereby substitute the Auckland Acclimatization Society's Game Farm at Cambridge in lieu of the Auckland Acclimatization Society's Game Farm at Drury as stated in clause twelve of the Schedule to the Warrant of the thirtieth day of March, which said Warrant is hereby amended accordingly.

As witness the hand of His Excellency the Governor, this twenty-seventh day of April, one thousand nine hundred and seventeen.

*Certain Area in Teviot Survey District declared a Sanctuary for Imported and Native Game.*

LIVERPOOL, Governor.

PURSUANT to the powers vested in me by the Animals Protection Act, 1908, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor of the Dominion of New Zealand, do hereby notify and declare that the area described in the Schedule hereto shall be a sanctuary for the purposes of the said Animals Protection Act, and that no imported game or native game shall be taken within the said area.

#### SCHEDULE.

ALL that area in the Otago Land District, being Block I, Teviot Survey District, comprising all lagoons in the Roxburgh Amalgamated Company's old workings, bounded on the south by the Molyneux River; on the east by the Teviot River and the main road; on the north by the main road, Roxburgh to Alexandra; and on the west by the Lady-smith Company's Claim.
