

WELLINGTON.—25th ultimo, on **two warrants** of commitment to Wellington Prison for (1) fourteen days in default of paying £2 7s. fine and costs, and (2) fourteen days in default of paying £2 fine and costs, for breaches of his prohibition order, **John Hyde**, age fifty-five, height 5 ft. 8½ in., labourer, native of England, medium build, fresh complexion, brown hair, blue eyes, scar on nose and on top of head.
