Public Service Association .- Police Ballot.

Office of the Minister of Justice, Wellington, 18th December, 1918. To the members of the Police Force.

Referring to my memorandum of 30th September published in the Police Gazette, 1918, page 577, the result of the ballot as communicated to me by Mr. Riddell, S.M., the scrutineer, is as follows:

Votes in favour of a separate Police Association Votes in favour of joining the Public Service Association 697 Votes against forming any association 34 Informal votes .. 38

I repeat my intimation that I have no objection to members of the Force joining the Public Service Association. The original notice published in the Police Gazette, 1913, page 474, has always remained and still remains in force. To enable the functions of membership to be exercised without conflict with the regulations, I purpose to recommend that the following proviso be added to Regulation 174: "Provided, however, that nothing in this regulation shall be held to prohibit members of the Force from becoming members of the Public Service Association of New Zealand.

I trust that the form of procedure to be adopted will ensure that every police member of the association shall be in-formed of the matters discussed, and have an opportunity of expressing his views and recording his vote.

I must, however, reserve to the Minister the full right to limit hereafter and define the matters which may be discussed and dealt with by virtue of association, and to safe-guard the preservation of discipline in such a manner as he

may think necessary.

In the meantime officers in charge of districts should place no obstruction in the way of members of the Force exercising the functions of membership of the association by way of attendance at meetings, but the routine of police duties must be adhered to.

I desire the police members of the association to hold their meetings in police premises and not elsewhere without special permission of the officer in charge of the district, and members of the executive of the association, but no others. may attend the meetings when necessary.
