

AUCKLAND.—30th ultimo, for theft of a heavy stock saddle, silver-plated under D's, white buck-skin let into large kneepads, slit near back D, folded leather girth, value £9, the property of **JOSEPH BELL**, livery-stable keeper, **Man** (name unknown), age about twenty-three, height 5 ft. 6 in., thin build, dark hair and complexion, small sunken mouth; dressed in a dark suit and felt hat. Accused hired the saddle from complainant for 5s., and has failed to return it. He was riding an aged chestnut mare with swollen legs. **No warrant.**
