

HAMILTON.—2nd December last, that he may be compelled to pay £3 3s. expenses incurred for medical treatment while on remand on a charge of attempted suicide, **Sydney Rolf Cox**, age thirty-seven, height 5 ft. 8 in., labourer and miner, native of England, medium build, sallow complexion, dark hair turning grey, brown eyes, pointed nose, skin has been burned off hands.
