

**TE KUITI.**—16th instant, on warrant for theft of a blue-serve suit, "Jaffe" on tag of coat, and a returned soldier's badge, No. 25/484, value £13 13s., the property of Terrence George Baker, Rora Street, identifiable. — **Smith** (name probably fictitious), age about twenty, height about 5 ft. 10 in., dark complexion, dark hair brushed back, tattooing on arms; dressed in green riding-breeches, faded blue-serve coat and vest.
