

HASTINGS.—31st ultimo, on warrant for failing to maintain his wife, Bepa Josephine Goodhead, Southampton Street, **John Henry Goodhead**, age thirty-one, height about 5 ft. 7 in. fitter and turner, native of England, strong build, fair hair and complexion, blue eyes, marks on face, birth-mark on one arm, spots on chest, one foot slightly turned in; dressed in a dark suit and light-grey-felt hat.
