

AUCKLAND.—15th ultimo, on warrant for failing to maintain his wife, Edna Harie Dallow, 1 Runnell Street, Ponsonby, and two children, Cyril Redwood Dallow, age twenty-five, height 5 ft. 6 in., labourer, native of New Zealand, medium build, fresh complexion, dark-brown hair, brown eyes, halving on left middle finger; dressed in grey trousers, navy-blue-serge coat, and black hat. *See 21/5/24*

HAMILTON.—18th ultimo, on warrant for indecent exposure, Alex Stewart (name probably fictitious), age about thirty, height 5 ft. 8 in., medium build, dark complexion and hair, thin face, large hooked nose, broad shoulders; dressed in a navy-blue shabby suit and tan boots. Accused indecently exposed himself in London Street within the view of Mrs. McElwee. He is identical with Man (name unknown) wanted for a similar offence at Hamilton.
