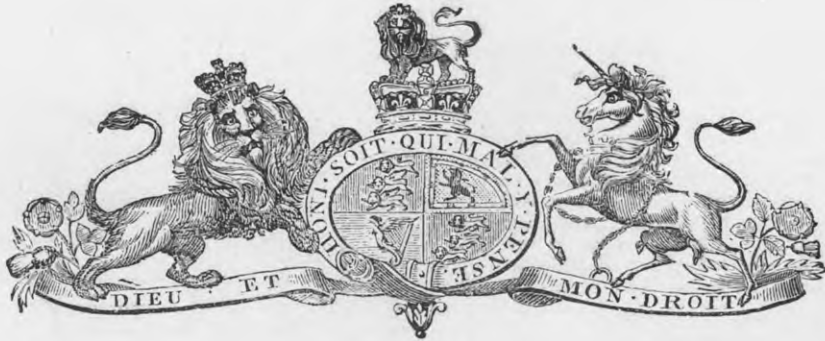

PERSONS WANTED.

DARGAVILLE.—John William Pye, failing to maintain: It has been ascertained by the Dargaville police that he served with the Expeditionary Force under the name **Wayfield**, and that he may be still going under that name. (See Police Gazette, 1923, page 493.) *arrested 8/1/30.*

Butters**, age thirty, height 5 ft. 10 in., carpenter, slight build, fair complexion, fair ginger hair, clean-shaved; dressed in a dark suit, cap, and white muffler; stooped.

AUCKLAND.—6th ultimo, on warrant of commitment to Auckland Prison for one month in default of paying £10 18s. arrears due on a maintenance order for the support of his child, **Clarence Hoyte**, age twenty, height 5 ft. 7 in., mill hand, native of New Zealand, medium build, sallow complexion, black hair brushed back, brown eyes, clean-shaved; well dressed in a blue suit, black-felt hat, and three-quarter-length tweed overcoat; sharp features. *paid 15.4.25.*

AUCKLAND.—28th April last, on warrant for false pretences, **Arthur Leopold Raven**, age forty-nine, height 5 ft. 7 in., land agent, native of England, medium build, florid complexion, fair hair turning grey, blue eyes, large round nose, ginger moustache, full face; dressed in a blue suit with white pin stripes, or an Oxford-grey suit and black hard hat, and wears rimless pince-nez; smokes "Turf" cigarettes. Accused obtained £100 from Austin Harry Paul, hairdresser and tobacconist, 95 Queen Street, by falsely representing that he had authority from James George Gallager to sell two houses in Sussex Street, Grey Lynn. He may endeavour to leave this Dominion.

AUCKLAND.—30th ultimo, on warrant for failing to maintain his wife, Jessie Louise Newman, 3 Day Street, Newton, **William Henry Newman**, age fifty-six, height 5 ft. 8 in., painter, native of England, medium build, fresh complexion, fair hair, brown eyes, front teeth decayed, lump behind left ear, crossed flags on left forearm, ring on left ring-finger; thin features; erect swinging gait.
