PERSONS WANTED.

AUCKLAND.—7th ultimo, for theft of carpenter's tools (some recovered), value £13 9s., the property of Albert Walter Perry, carpenter, 374 Manakau Road, Epsom, **John Hurley**, age about thirty-seven, height 5 ft. 10 in., strong build, dark complexion and hair; dressed in a dark suit and dark-brown felt hat. The tools were stolen from a shed on the King's Wharf and sold to a second-hand dealer by the man described above. **No warrant.** *arrested 25/2/25.*
