

AUCKLAND.—17th instant, for breaking and entering the shop of William McKinney, chemist, New North Road, Mount Albert, with intent to commit a crime, **Two Men** (names unknown)—(1) age about twenty-three, height about 5 ft. 7 in.; wearing light-grey close-fitting overcoat with belt and a felt hat; and (2) age about twenty-three, height about 5 ft. 5 in.; dressed in a brown suit. They were seen in the shop, and left in a grey Ford motor-car. **No warrant.**
