

PALMERSTON NORTH.—22nd ultimo, on two warrants of commitment to Wellington Prison for two months and one month in default of paying £11 2s. arrears due on maintenance orders for the support of his wife and child, **George Annabell**, age forty-eight, height 5 ft. 8 in., carpenter, native of New Zealand, stout build, fair complexion, brown hair turning grey, blue eyes, fair moustache, scar on left side of nose, one ankle stiff, walks with a limp; usually dressed in a grey suit and grey felt hat.
