A description of property supposed to be stolen, found in the possession of offenders, for which owners cannot be found, shall be furnished for insertion in the Gazette.

## PERSONS WANTED.

**WHANGAREI.**—1st instant, on **warrant** for failing to comply with the terms of a maintenance order for the support of his wife, Mabel Cummings, Kamo, and children, **David Cummings**, age forty-two, height 5 ft. 9 in., miner and labourer, native of New Zealand, medium build, pale complexion, dark hair, large brown eyes; scars on right knee, which is injured; pinched features; dressed in a grey suit and black felt hat; walks with a slight limp. **AUCKLAND.**—**Henry Edward Laverty**, forgery: The remaining four money-orders stolen by accused from Clevedon Post-office were each forged for £40, and paid at Melbourne (Australia) on the 1st December last. On each order the remitter

was shown as "J. Gore," and the payee "H. Gore." The writing is identical with that on the money-orders forged at Auckland. (See Police Gazette, 1928, page 147.)
