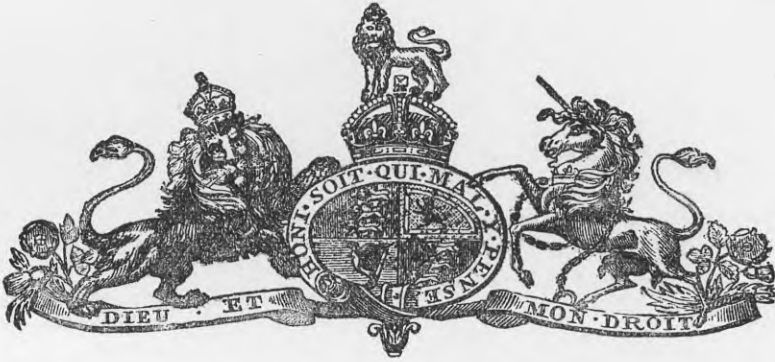

Arson.

TE AROHA.—About 8 p.m. on the 18th ultimo two stacks of hay, value £76, the property of David Burgess and William George Revell, farmers, Wairongomai, were wilfully destroyed by fire. Any information regarding the offences is to be communicated to the Inspector of Police, Hamilton.

PERSONS WANTED.

AUCKLAND.—9th ultimo, on **warrant** for assault causing actual bodily harm, **Alfred Collins** (name probably fictitious), age about twenty-five, height 5 ft. 6 in., medium build, fair complexion and hair, blue eyes; dressed in a blue serge suit and grey felt hat. Whilst escorting Mary Agnes Pickles, domestic, 9 Vincent Avenue, Remuera, home from a dance at Newmarket, accused attempted sexual intercourse with her. She resisted and screamed, whereupon he violently assaulted her. *Arrested 19-6-29.*
