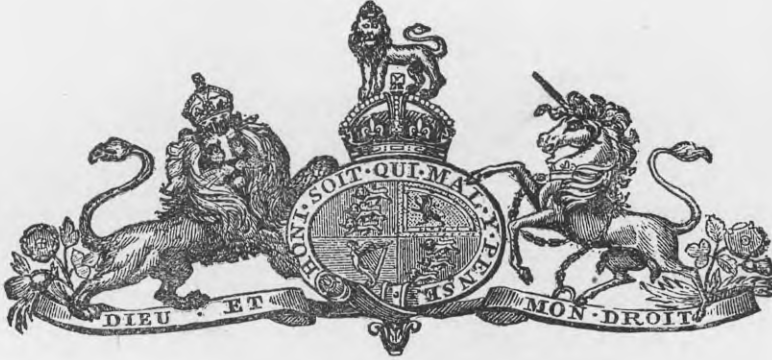

When notifying the arrest of persons charged with theft, or suspected of theft, it should be stated whether the property stolen, or any portion of it, has been recovered.

A description of property supposed to be stolen, found in the possession of offenders, for which owners cannot be found, shall be furnished for insertion in the Gazette.

All communications concerning this Gazette should be addressed to the Commissioner of Police, Wellington, and the envelope marked "For Gazette." Members of the Force in charge of out-stations will forward them **DIRECT**.

## SPECIAL NOTICES.

### Unidentified Body.

**PUKEKOHE.**—On the 21st ultimo, the skeleton of a **Man** (name unknown) was found at Patumahoe, death having probably taken place about two years ago. Description: Age about forty-eight, height about 5 ft. 8 in., medium build, brown hair turning grey and going bald, artificial upper teeth with one tooth missing on each side, seven natural front teeth in lower jaw with artificial teeth attached on each side with gold clips; dressed in a grey suit, greenish-grey felt hat with black band, "J. R. Self, Ltd., Auckland," on

inside band, greenish-white shirt with small purple and black stripes, black and purple silk bow tie, boots size 9, well worn, half soled, and heavy grey woollen socks. A pipe, metal watch, tooth-brush, comb, small white compass and mirror combined, and £1 14s. 11d. in money was found on the body, and beside it a bottle which had contained strychnine. Any information regarding the identity of the deceased is to be forwarded to the Superintendent of Police, Auckland.
