

WAIHI.—30th ultimo, that he may be interviewed regarding his having failed to notify his change of address (Arms Act), **George James Scothern**, referred to in Police Gazette, 1930, page 338. He may be in possession of a .45 calibre six-chambered Colt revolver, No. 455, and certificate of registration No. 137675.

HAMILTON.—12th May last, for forgery and uttering, **Man** (name unknown), age about forty-seven, height 6 ft., slight build, sallow complexion, brown eyes, black moustache, large feet; dressed in a navy-blue suit with tight trousers which have an overlapping seam, soft collar, black tie, and fawn felt hat. Accused forged the signatures of C. C. Cairns and F. Woodward to a cheque for £25, and uttered it to Margaret Burch, wife of licensee Waikato Hotel. The cheque is from one of two cheque-books which disappeared from the premises of Cairns and Woodward, Auckland, when they were destroyed by fire on the 16th February last. **No warrant.**

WHAKATANE.—29th ultimo, that two summonses may be served upon him for unlawfully killing native game, **Tirau Mohi**, alias "**Davey**," age about thirty-five, height 5 ft. 7 in., labourer, strong build; a Maori; speaks good English.

NEW PLYMOUTH.—3rd instant, on warrant for being idle and disorderly (no lawful means), **Evelyn Marjorie Swindells**, age seventeen (born 24th August, 1913), height about 5 ft. 4 in., native of New Zealand, good build, fair complexion and hair, blue eyes; dressed in pleated skirt with black stripes, grey stockings, black shoes, black and white check coat with black beaver collar, and black velvet hat. Her moral character is not good. She may endeavour to leave this Dominion.

NEW PLYMOUTH.—18th February last, on warrant for theft of a gramophone (recovered), value £9 10s., the property of La Gloria Gramophone Co., **Fred Wood**, age about thirty-five, height 5 ft. 8 in., hairdresser, native of New Zealand, strong build, fresh complexion, fair hair, grey eyes; usually well dressed in a grey suit and grey felt hat. WANGANUI.—30th ultimo, on warrant for false pretences, **D. Reid** (name probably fictitious), age about forty, height about 5 ft. 10 in., medium build, fresh complexion, brown hair; wearing oilskin overcoat and light felt hat; Scotch accent. Accused obtained £1 from Thomas George McGovern, licensee Upokongaro Hotel, by means of a valueless cheque for that amount. The cheque was from a cheque-book, No. 2/A 115831 - 2/A 115860, issued by the Union Bank of Australia, Wanganui, to **Annie Black**, who opened a small account recently. She is associated with accused (and they are in possession of a motor-car, registration No. 4-317 or 14-317), and her description is: Age about forty, strong build; wearing brown overcoat with large white or grey squares. **No warrant** has been issued for her arrest. They are suspected of breaking and entering the Alton Store on the night of the 30th ultimo, and other offences. WAKEFIELD.—10th April last, for failing to comply with the conditions of his release upon probation (Offenders Probation Act, 1920), **Arthur Frederick Richard Rohloff**, alias **Major Rohloff**, age thirty-seven, height 5 ft. 10 in., clerk and labourer, native of New Zealand, medium build, fair complexion and hair, blue eyes, scar on back and on left arm, suffers from T.B., erect gait; well educated. On the 9th August, 1929, at Nelson, he was convicted of theft, and released on probation for two years.
