Disqualification from obtaining Motor-driver's License removed.

PERSONS WANTED.

AUCKLAND.—11th instant, for assault and robbery, **Man** (name unknown), age about twenty-five, height about 5 ft. 6 in., medium build; wearing a grey overcoat and slouch hat; deep voice. About 3 a.m. accused requested Warwick Francis Harvey, taxi-driver, to drive him to Hillsborough Road, where he assaulted the driver and robbed him of £1 15s. **No warrant.**

AUCKLAND.—21st instant, that two orders committing her two children to the care of the Education Department may be served upon her, **Annie Steele Rudd Hall**, age thirty-five, height about 5 ft. 5 in., cook, native of New Zealand, medium build, pale complexion, short fair hair, hazel eyes; dressed in a light-brown dress, brown hat, and shoes, and nigger-brown overcoat; wears glasses.

AUCKLAND.—29th July last, on **warrant** of commitment to Auckland Prison for six months in default of paying £164 9s. 6d. arrears on a maintenance order for the support of his wife, Fanny May Bancroft, 2 East Street, Newton, **Alfred John Bancroft**, age forty-eight, height 5 ft. 4½ in., hairdresser, native of England, strong build, fresh complexion, grey hair, blue eyes, scar on right leg and thigh. He may be accompanied by Alice Casey (age about forty, slight build, fair complexion and hair), and they may be travelling in an Essex Sedan motor-car, registration No. 25-758. He may endeavour to leave this Dominion.
