

TE AROHA.—3rd instant, that proceedings for failing to notify his change of address may be instituted against him (Arms Act), **Percy Edmund Knyvett**, age about fifty-five, height 5 ft. 11 in., farmer and land-agent, native of New Zealand, medium build, fresh complexion, dark-brown hair turning grey, blue eyes; wears spectacles. On the 2nd November, 1921, he registered a .22 calibre single-shot Winchester rifle.
