

PALMERSTON NORTH.—31st ultimo, on warrant of commitment to Wellington Prison for fourteen days in default of paying £4 ls. arrears on a maintenance order for the support of his wife, Winifred Eileen James, 9 Keeling Street, **Joseph James**, age twenty-three, height 5 ft. 6½ in., labourer and box-maker, native of New Zealand, medium build, pale complexion, fair hair, grey eyes, long nose, scar on chin, two burn-scars on right arm, scar on inside of right shin; smart appearance.

KIMBOLTON.—7th instant, that proceedings for failing to notify their change of address may be taken against them (Arms Act) (1) **Douglas Bengel**, labourer. On 14th December, 1922, he registered a .22 calibre Stevens repeater rifle, No. T. 247; (2) **Vivian Ambrose Phillips**, contractor. On the 23rd June, 1923, he registered a .22 calibre B.S.A. rifle, No. 29655, model 1902; and (3) **James Henry Evans**, labourer. On the 16th April, 1923, he registered a .22 calibre Winchester repeating rifle, No. 602084.

WELLINGTON.—On or about the 11th July, 1930, on warrant for false pretences, **Ernest Mabin Gilmour**, age thirty-eight, height 5 ft. 9¼ in., company-manager, native of New Zealand, medium build, fresh complexion, fair hair, hazel eyes, four moles near left eye; smart appearance. On or about the 11th July, 1930, accused obtained £200 from William Claus Hanson, coal merchant, Constable Street, by falsely representing that the Craftsman Manufacturing Co. of New Zealand, of which he was the managing director, had the patent rights in New Zealand of a motor-car head lamp-reflector. There are other charges pending. (See Police Gazette, 1930, page 365, and Photographs, 1928, page 8.) (See also following paragraph).

WELLINGTON.—On or about the 10th October, 1930, on warrant for false pretences, **Charles Ernest Vickers**, age about fifty, height about 5 ft. 9 in., company promoter, native of Australia, stout build, fresh complexion, auburn hair, brown eyes, one eye slightly closed, very much wrinkled at corners of eyes, small ears; about 18 st. weight. In July, 1932, he was in Johannesburg, South Africa. Accused arrived from Melbourne, Australia, early in 1930, and with Ernest Mabin Gilmour and Frederick A. Kelly, floated a company known as the Craftsman Manufacturing Co. of New Zealand, Ltd. He is charged that at Mania, on or about the 10th October, 1930, he obtained, through his agent, Archibald David McKinley, £1,000 from James John Patterson, farmer, by falsely representing that the Craftsman Manufacturing Co. of New Zealand had purchased the patent rights of a motor-car head lamp-reflector for New Zealand, that the dies used in the manufacture of the reflector had cost his company in New Zealand £12,000, and that they had been selling five hundred reflectors per month since establishing the company in New Zealand. There are other charges pending. (See preceding and following paragraph).

WELLINGTON.—On or about the 20th January, 1931, on warrant for false pretences, **Frederick A. Kelly**, age about fifty, height about 5 ft. 4 in., salesman, native of Australia, strong build, swarthy complexion, dark hair turning grey, blue eyes; wears a circular gold tie-pin set with a single stone, and wears a gold ring, set with three diamonds. Accused obtained £325 from James John Patterson, farmer, Mania, by falsely representing that the Craftsman Manufacturing Co. of New Zealand had altered its method of business, and had bought four large premises in the four centres of New Zealand, and to provide more funds the company had allowed original shareholders to take a certain proportion of fresh shares at the original price. There are other charges pending. (See preceding paragraphs.)

WELLINGTON.—5th ultimo, for failing to comply with the conditions of his release upon probation (Offenders Probation Act, 1920), **Arthur William Rose**, age nineteen, height 5 ft. 7 in., labourer, native of New Zealand, slight build, pale complexion, dark-brown hair, hazel eyes, three scars on buttocks; usually dressed in a navy-blue suit (no hat); quiet manner; slouching gait; attends Communist meetings. (See Police Gazette, 1932, page 485.)

WELLINGTON.—9th instant, for failing to comply with the conditions of his release upon probationary license, **Cyril Cedric Walker**, referred to in Police Gazette, 1932, page 549, and Photographs, page 7. His license has been cancelled, and his return to the nearest Borstal Institution is desired. His license expires on the 11th August, 1933, after which he is not to be arrested, but if he is located after that date and before August, 1934, he is to be warned to report to the nearest Probation Officer. (P. 33/717.)

NELSON.—5th instant, that proceedings for failing to notify his change of address may be instituted against him (Arms Act), **William Zeinert**, miner. On the 18th September, 1922, he registered a .303 calibre rifle, No. 1896.

WESTPORT.—1st instant, on warrant for failing to comply with the terms of a maintenance order for the support of Keturah Holman, **William John Holman**, age forty-one, height 5 ft. 8 in., miner, native of England, medium build, dark complexion, curly black hair, dark-brown eyes, one front tooth missing; woman on left forearm; usually dressed in a blue or grey suit and light felt hat; fond of drink. Arrears to 10th ultimo, £21 3s.

Accused obtained 12s. from John Warren Abernethy, builder, by falsely representing that he was printing a calendar, which would be posted about Christmas, 1932, in which complainant's business would be advertised. There are other charges pending.

CHRISTCHURCH.—23rd ultimo, on warrant of commitment to Paparua Prison for fourteen days in default of paying £49 10s. arrears on a maintenance order for the support of his child, **William or Wilmore Morrison McMillan**, age thirty-one, height 6 ft. 1 in., labourer, native of New Zealand, strong build, fair complexion and hair, blue eyes, large ears; dressed in a navy-blue suit, light felt hat, and navy-blue or leather overcoat.

DUNEDIN.—2nd instant, for escaping from Seacliff Mental Hospital, **William Harper**, age twenty-nine, height 5 ft. 8 in., labourer, native of New Zealand, medium build, sallow complexion, dark-brown hair, black moustache; dressed in brown moleskin trousers, dark striped denim coat and vest, and Blucher boots (no hat).
