

NELSON.—30th June last, on warrant for obtaining credit by fraud, **Thomas Taylor**, alias **Thompson**, referred to in Police Gazette, 1933, pages 524 and 552. He obtained on credit a pair of boots and a pair of shoes, value £3 5s., from Messrs. Hallenstein Bros., by fraudulently concealing the fact that he was about to leave the Dominion for Australia. He was accompanied by Mrs. Jean Bain, referred to in preceding paragraph. There are other charges pending.
