

WELLINGTON.—10th October last, on warrant of commitment to Wellington Prison for one month in default of paying £10 15s. arrears on a maintenance order for the support of his child, **Clifford Lindolph Richards**, age twenty-eight, height 5 ft. 9 in., taxi-driver and musician, native of America, fresh complexion, fair hair, blue eyes, large nose, small fair moustache, side whiskers; usually dressed in a navy-blue suit, light-coloured felt hat turned down in front; good build; an accomplished dance musician, and plays a saxophone.
