

of the words "Guarantee received" will be sufficient; in such case, however, the guarantee must be forwarded to the Commissioner's Office without delay.

13. Stray Cattle, &c.—No notification of lost horses or cattle will be published in this Gazette unless they be Government property; but notices of horses or cattle believed to be stolen will be inserted.

14. Supplementary Reports.—In all reports respecting cases gazetted members of the Force will quote the year and page of the Police Gazette in which the previous notice has appeared, and in reporting arrests or locations of persons inquired for should state by whom effected. Supplementary reports of cases already reported, but not gazetted, where arrests are made or stolen property recovered, should at once be forwarded to the Commissioner's Office, and should contain such information as will clearly identify the case.

15. Warrants.—All reports of crime must state whether or not a warrant has been issued for the arrest of the offender, and, if a warrant has been issued, the date of issue, and by whom and where issued, should be stated. Should a warrant not have been issued in the first instance, but one be subsequently obtained, a supplementary report announcing the issue must be immediately forwarded to all places where the original report has been sent. The supplementary report should give the date of the original crime report, or quote the year and page of the Police Gazette in which the previous notice has appeared. Persons reporting crimes shall be requested to obtain warrants whenever practicable. Crime reports relative to commitment warrants should give the full amount due, including cost of warrant, the term of imprisonment in default, and the gaol to which the committal is made. Unless there are some good reasons to the contrary particulars of distress warrants will not be published in the Police Gazette.

16. Duties of Officers in Charge.—Officers in charge of Stations shall:—

- (1) Cause the Police Gazette to be carefully filed.
- (2) Cause to be marked off in the Police Gazette (showing particulars) all arrests, recovery of property, missing friends located, &c., as notified in any subsequent Gazette.
- (3) See the Police Gazettes are not torn, defaced, or injured, or improperly removed from the files, offices, or police building.
- (4) Be held responsible that reports forwarded from their Station for insertion in the Police Gazette are properly formulated.

Failure to observe and disobedience of these "General Instructions" shall be treated as a disciplinary offence under the Police Regulations.

Convictions to be cancelled.

LUMSDEN.—The convictions recorded against **Leslie Patterson** and **Frank William Lamond** in Police Gazette, 1934, page 609, are to be cancelled in all copies of the Gazette. At a rehearing on the 3rd ultimo the charge of assault against **Patterson** was dismissed, and **Lamond** was sentenced to one month.

AUCKLAND.—12th ultimo, on warrant of commitment to Auckland Prison for one month in default of paying £10 arrears on a maintenance order for the support of his illegitimate child, of whom **Noella Frances Oliphant** is the mother, **Percy Morrison**, age twenty-six, height 5 ft. 10 in., mill hand, native of New Zealand, slight build, fair complexion, brown hair, blue eyes; dressed in a navy-blue suit and black boots.

AUCKLAND.—8th ultimo, on warrant for theft of a motor-car (recovered), value £80, the property of John Stewart Dickinson, **Jack Simmonds**, alias "**Crisp**," age about twenty, height about 5 ft. 8 in., seaman, native of Australia, strong build, tanned complexion, long curly light-brown hair, hazel eyes, pug nose turned up at tip, double lobe on right ear, pimples on face; usually well dressed in a light-blue suit with double-breasted coat (never wears a hat); rolling gait with head erect; said to be well educated. He may try to leave this Dominion. Accused sold the car to Arthur Patterson, 5 Columbia Road, for £15.

TAURANGA.—On or about the 24th November last, on warrant for theft of five steel wedges (recovered), and a steel hammer, value 12s. 6d., the property of Leslie Wilfred Basley, Pyes Pa Road, **Percy Sewell**, age twenty-eight, height 6 ft., labourer, native of New Zealand, thin build, fresh complexion, brown hair, hazel eyes, prominent ears; stooped. He may be identical with **Edward Edgar Gray Dickson**, referred to in Police Gazette, 1934, page 138.

HASTINGS.—1st instant, that he may be located and interviewed regarding his having committed bigamy, **Robert Edward Parkes**, alias **Robert Arthur Parks**, referred to in Police Gazette, 1933, page 571, and Photographs, page 37. He is now described as being forty-one years of age. On the 6th November, 1912, he married Bridget Elizabeth Scannell at Stratford, and on the 10th January, 1927, while his wife was still living, he went through the form of marriage with Caroline Ruth Crump at Waverley. When located, the file is to be obtained from the Inspector of Police, Napier, before he is interviewed.

WANGANUI.—15th ultimo, that he may be interviewed regarding non-payment of his unemployment levies, **Roy Arnold Allen**, age thirty-nine, height 5 ft. 8 in., salesman, native of New Zealand, medium build, dark complexion and hair. He is in possession of coupon-book, No. 262313.

WELLINGTON.—27th October last, on warrant for theft of £5, the property of John Spence, 8 McKenzie Terrace, **Frank Wilson**, age fifty-four, height 5 ft. 7 in., labourer, native of England, medium build, pale complexion, auburn hair, blue eyes, large nose, scar on left ear, on upper lip, and on left ring-finger. Accused, who was janitor in the Commercial Travellers' Building, Victoria Street, was given by John Spence, secretary of the Returned Soldiers' Association, £5 to pay to Dr. Elliott. He failed to pay over the money, left his employment, and subsequently admitted to complainant that he had spent the money. He also stole a bicycle, the property of the Returned Soldiers' Association, and sold it to a second-hand dealer. An information in respect of this offence has been laid against him. WELLINGTON.—14th November last, for false pretences, **Allan**, age about twenty-four, height 5 ft. 8 in., medium build, fresh complexion, fair wavy hair, blue eyes; dressed in brown trousers, grey coat torn under arms (no hat). Accused obtained £1 from Anne Edge, proprietress of the Hotel Bristol, Ghuznee Street, by means of a valueless cheque for £8 15s., signed E. T. Williams. Complainant refused to give him any more money on the cheque, but held it as security for £1 5s. which accused owed her for board and lodging. He is believed to be identical with **Alan Edward Taylor**, alias **Allen Taylor**, referred to in Police Gazette, 1934, page 690, and Photographs, 1932, page 65. **No warrant.**

WELLINGTON.—26th ultimo, on warrant for failing to comply with the terms of a maintenance order for the support of his wife, **Venessa Rita Glover**, 10 Jacobs Place, **Arthur George Maxwell Glover**, age twenty-two, height 6 ft., seaman, native of New Zealand, strong build, dark complexion, dark-brown hair, blue eyes, small nose and ears, round face, good teeth, "Bonny" and lion's face on right forearm, ship on right upper arm, small ship on left wrist, eagle and shield on left forearm, Japanese woman on left upper arm, large butterflies on front of each foot; well spoken; erect gait; fond of drink. He is believed to be a member of the crew of the s.s. "Queen Eleanor," which left Westport on the 24th ultimo, but is expected to return to some New Zealand port in about a month.
