

PROPERTY STOLEN.

AUCKLAND.—On the 9th November last, the dwelling of FANNY AMELIA WATSON, 9 New Bond Street, Kingsland, was broken into and the following stolen: A greenstone heart, about 2½ in. deep, "F.A.W." in gold letters on it; a greenstone brooch, about 2½ in., by ½ in., "N.Z." in gold letters on it; and five gold medals about size of a florin, each bearing inscriptions as being won for pigeon flying, and having on them "W.
