Colonel Moore hastily drew his hand over his face, as though trying to wipe away some unpleasant reminiscence, and then said in a low voice: 'Captain, had you made this request at any other

But, as you have said, life is very uncertain now, and we must disregard conventionalities, I will deliver your message when I have the opportunity. Good-night.'


Presentation to Rev. C. J. Venning, S.M., Brooklyn
