Officers in charge of stations are requested to report to the Commissioner of Police every instance of the non-delivery of the GAZETTE, and to suggest from time to time such alterations in the addresses and in the mode of transmission as may be considered necessary. 2.—Warrants.— Whenever it is desired that

any individual whose name is given, shall be apprehended, it should be stated in the advertisement for the GAZETTE whether or not a warrant has been issued for the apprehension of the offender. When a warrant has not been issued in the first instance, any subsequent re-port announcing the issue of a warrant should repeat the offender's description.

3. Names.— It is particularly requested that in all Informations the names of persons and places may be spelt correctly, and writtenlegibly, the Christian name being given with the surname whenever possible, and written in full to prevent mistakes.

4. STRAY CATTLE .- No advertisements of lost horses or cattle will be published in this Gazette unless they be Government property, but notices of horses and cattle believed to be

stolen will be inserted gratuitously.

5. PROPERTY DESCRIBED.—In forwarding the brands of stolen horses and cattle, it should be stated of what hind of letters the brand consist, whether of Roman capitals, or in writing, &c., and the exact position of the brands should be given, and be imitated as nearly as possible. or given, and we imitated as nearly as possible. In giving descriptions of watches, it should be stated whether they are open-faced, hunting, double-cased, or half hunting,—the term "double-cased" being reserved for those watches whose outer case is removed in order to wind; "half-lunting" including a the hunting" implying a very small glass in the metal cover of the dial.

6. REWARDS .- No notice of reward offered by any private party or parties will, for the

future, be inserted in the Police Gazette, unless there be forwarded to the Commissioner of Police the guarantee of some responsible person that the reward shall be payable accord-ing to law, on the arrest or conviction of the offen-

der, and not merely for the recovery of property,
7. Previous Police Gazette References.—It is requested that on the arrest of any offender Gazetted, or on information being obtained for which a reward has been publicly offered, or respecting notices published in this GAZETTE, officers in charge of Police, or others concerned, will be good enough to forward intimation thereof to this office, quoting the date and page of the GAZETTE in which such notice has appeared.

HIGHWAY ROBBERY UNDER ARMS.

At 11 a m., the 2nd November, 1863, as Mr. William Acton, of Switzer's Diggings, storekeeper, was proceeding therefrom to Invercargill via the Pyramid, on horseback, when about eight miles from Switzer's, and the when about eight miles from Switzer's, and the like distance from the Pyramid Camp, he was stopped by three armed men, one having a double barrelled gun, the other two revolvers, who fired upon and slightly wounded him, and robbed him of over 60 oz. of gold, some of it pretty coarse, some very bright and scaly, and some of it dark, being coated with nitrate of iron. £30 in sovereigns and balf sovereigns. of iron, £30 in sovereigns and half sovereigns, eight £5 notes, a patent English lever hunting watch, made by John Edwards, Liverpool, No. 7202, and a self-acting revolver. The men are thus described by him:—

1st. About 27 years' old, 6 feet high, well huilt, but not very stout, light brown hair and bushy sandy whiskers not very long; dressed in blue monkey jacket with red liming; torn inside across the shoulder, small Bedford cord trousers, light grey Crimean shirt, drab billycock hat, and low boots.

2nd. About 30 years' old, 5 feet 9 inches high, squints a little with one eye, supposed the right, dark complexion, dark bushy whiskers, dark hair; wore blue cloth monkey jacket, moleskin pants, dark billycock hat, and short boots.

3rd. About 35 years' old, about 5 feet 6 inches high, thin features, light complexion, light brown harr, small whiskers; wore a broad body belt tied with strings, moleskin pants, billycock hat, and short Wellington boots cut in shreds across the toes.

The double barrelled gun had a highly finished stock inlaid with gold or brass, the maker's name in same metal between the barrels, the hammers representing the heads of some animals. One of the revolvers was a large sized Colt's, the other a pepper box.

It has been subsequently reported by Sergeant Hewson, of the Mounted Escort, that a gun answering exactly to the above description, the hammers or cocks representing dolphins, was seen by him on the 12th of October, 1863, at George Fletcher's Accommodation House, at the Elbow, in the Province of Southland. A reward of £20 will be paid to any person giving such information as shall lead to the apprehension of the offenders.

At 8.30 a.m. the 12th December, 1863, as Mr. Skinner, Agent for the Bank of New Zealand, Dunstan Branch, was proceeding from the Dunstan to the Nevis, to purchase gold, he was stuck up by two armed men (masked) who assaulted and robbed him of the following property:—

DESCRIPTION OF THE MEN.

First, tall and stout, hair and complexion supposed dark, dressed in moleskin trousers and dark billycock hat, carried a gun.

Second, shorter, hair and complexion supposed fair, carried a revolver.

Two men, Thomas Murphy, alias Parker, alias Williams, and Thomas Cunningham, alias Clifford, alias Stewart, have leen apprel ended, and a portion of the money found on them.

HORSE AND CATTLE STEALING,

Stolen about the 10th of October, 1863, from the vicinity of Oamaru, 1 dark roam mare, branded $_3^{\rm J}{\rm G}$ on near shoulder, white hair on top of tail, and some white hairs on the neck caused by a tether rope; 1 bay horse, branded $_{\rm V}{\rm L}$ off shoulder, switch tail; and 1 bay gelding, NI near shoulder, long tail; the property of Messrs. Skriniski and Moss, of Oamaru.

Stolen about the 30th November, 186 from a mob of horses, at Lammerlaw Cree near Waipori, a black horse, 12 hands high stout built, short tail, a few white hairs a forchead, branded R near shoulder; the preperty of Mr. Samuel Nichols of Waipori.

Suspicion attaches to one of the servants.

Stolen between the hours of 8 p m. the 9th, and 8 a.m. the 10th December, 1863, from off a buggy, which was left in Park-street, Dunedin, a canvas cover, 12×10, marked by the rust from the wheels; the property of Mr. Robert Gillies, of Park-street.

Stolen between the 12th and 16th December, 1863, from a box which had been left under the verandah of the officers' quarters at the Military Barracks, Dunedin, about 80 volumes of books, the property of George Abrams, Esq.; many of them had been school and college prizes awarded to him, and bore the arms of Clare College. The following formed a portion:—Keat's Poetical Works illustrated, Southey's do., Kirkwhite's Poems, Hallam's Middle Age, Muller's Greek Literature, Hood's Poems, Coleridge's do., Keddell and Scott's Greek Lexicon, and 2 Thermometers, maximum and minimum, by Regretti and Zambui.

PROPERTY LOST AND LOUND.

Found in the possession of John, James, and Thomas Frost, now under committal for trial for horse stealing, and supposed to be stolen, a bay horse, draught breed, 15 hands, black points, saddle marked, white spots on both sides, branded JJ near neck, J OB conjoined off neck.

Lost between 5 and 6 p.m. the 12th instant, from the person of James Pringle, between Caversham and Stafford-street, Dunedin, a silver patent lever hunting watch, engineturned, maker R. Stewart, No. 49588, with silver guard chain and 2 gold keys attached.

INQUESTS.

A magisterial inquiry was beld on the 31st August, 1863, at the Boundary Creek, Switzers, by J. N. Wood, Eq., Resident Magistrate, on the body of Joseph Paul, aged 40 years, a baker, who died suddenly at the tent of one Daniel Robinson, at Boundary Creek, on the 28th August, 1863. Verdiet, died from Natural Causes.

A coroner's inquest was held on the 15th of December, 1863, at Cooper's Family Hotel, Dunedin, by T. M. Hocken, Esq., coroner, on the body of Robert German alias Sinclair, aged 36 years, an accountant, who died on the 15th December, 1 63, while being removed from H.M. Gaol, Dunedin, to the Dunedin Hospital, at the time under sentence for

drunkenness. Verdict—Serous apoplexy, caused by habits of intemperance. His wife and family are reported to be living on the Navarre Diggings, Victoria.

A coroner's inquest was held on the 7th December, 1863, at the Café de Paris, Jettystreet, Dunedin, by T. M. Hocken, Esq., coroner, on the body of John Thompson, aged 45 years, a sailor, which was found in the Dunedin harbor on the morning of the 6th December, 1863. Verdict, Found Drowned.

A coroner's inquest was held on the 17th December, 1863, at the residence of Vincent Pyke, Esq., Dunedin, by T. M. Hocken, Esq., on the body of Margaret Lynch, aged 22 years, house servant, who was accidentally killed, on the 16th December, 1863, by a tree falling on her. Verdict accordingly. Deceased had relatives residing in Dunedin.

MISSING FRIENDS.

Information requested by the friends of Peter Johnson, of Richmond, Victoria, of his present address, he having left Richmond for Otago some time since, and was last heard of from the Dunstan.

Information is requested of the present whereabouts of John Thomas Lister, 14 years old, tall, very upright, brown hair, blue eyes. He left Newcastle, New South Wales, in the barque Cincinnati, in September, 1862, and was last heard of at Queenstown, Otago, about 4 months since, when he was discharged from the service of Mr. Thatcher, the vocalist. Was supposed to be with some carriers working on the Dunedin or Invercargill Roads.

Information is requested of the present whereabouts of David Green, aged 21 years, 5 feet 4½ inches high, fair complexion, brown hair, slight whiskers, full face. He was last heard of by his brother in the month of July last, at which time he was living with Mr. Joseph Rendall, Manuherikia bakery. He left that in company with James Gardiner and James Drew, for the purpose of digging in the direction of Campbell's.

WILFUL MURDERS.

ONE HUNDRED POUNDS REWARD.—FREE PAR-DON TO AN ACCOMPLICE.

Whereas William Selby and John Bennett, hawkers, having left Stawell on Friday, the 16th of October last, with a large amount of jewellery and other goods for sale, were discovered on Friday, the 6th of November inst., near Mr. Dennis's station on the Richardson River, tied up to a tree and murdered: Notice is hereby given that there will be paid by the Government for such information as shall lead to the apprehension and conviction of the offender or offenders guilty of murdering the persons above mentioned, One hundred pounds, or Fifty pounds for each offender if it should be proved that there were more than two offenders.

PARTICULARS TO AID DETECTION.

The first of these men is supposed to be English, aged 35 or 40, 5 feet 10 or 11 inches high, stontish built, 12 or 13 stone weight, fair and fresh complexion, light hair, large and bushy sardy whiskers worn all round the face, moustache, unshaved, rather full features, large head, straight nose, somewhat prominent chin, long arms, large hands, clumsy and slovenly appearance, flash manner, and ordinary bush costume. He carried a revolver and sheath-knife, and wore two much-worn gold rings, one of them engraved with J. W. on shield. He seemed to be a very indifferent horseman.

The second man looked like a "native," but may be English-born, and had the appearance of a "loafer" and horsestealer, aged 30 or 35, f. et 7 or 8 inches high, medium build, about 11 stone weight, sallow or dark complexion, brown hair, darkish thin and straggling whiskers and beard, unshayed, straight nose, repulsive countenance, active gait, and ordinary bush costume. He also carried a revolver and sheath-knife.

One of the revolvers is an old six-barrelled one, the trigger-guard fastened on with a nail instead of a serew.

One of the men signed himself James Martin.

About 10 a.m. the 2nd instant, James Coffee, Farmer, near Burrowa, was stopped at Coffee's Creek, near Burrowa, by two armed men, John Gilbert, and Ben Hall, and robbed of £37. These offenders are said to have stopped and searched several other persons

about the same time and place.

About 3 p.m. on the 5th instant, the mail from Burrowa to Binalong, was stopped about 2 miles from Smelly's Creek, and about 6 miles from Burrowa. by two armed men, John Gilbert, and Ben Hall, and robbed of the mail bags, which the offenders cut open and rifled of their contents; there was one man on the mail whom the offenders did not attempt to rob. They gave the mailman a large-sized gold watch to give to Mr. Scott, Burrowa.

DESCRIPTION.

John Gilbert, about 21 years' of age, 5 feet 8½ inches high, slight active figure, brown hair not very long, no bair nor any particular marks on face, light grey laughing eyes, round nostrils, thick lips, care-worn in appearance.

Ben Hall, about 28 years' of age, 5 feet 9 inches high, stout build, (would weigh about 13 stone 7 lbs.), figure erect, respectable appearance, light brown wavy hair, short light beard, thick, but darker near his throat, and very pleasing expression of countenance, soft grey eyes, handsome nose inclined to be hooked, and this compressed lips.
