Felonies and other Offences.

A warrant has been issued by the Riverton Bench for the arrest of Maori Bill, alias W. E. Thompson, alias Kelly, alias Healy, charged with obtaining £5 and a silver watch and chain by false pretences, from Thomas Price at Otautau, on the 23rd December last and 1st ultimo. Offender is an American, Irish decent, a railway labourer, about 42 years of age, 5 feet 11 inches high, thin dark features, thin black hair mixed with grey, bald on top of head, cheeks shaved, Yankee beard and moustache, dressed in blue cloth coat, grey tweed trousers, and black hat. This offender has committed several other offences of a similar nature.

A warrant has been issued by the Port Chalmers Bench for the arrest of Charles Johnson, charged with deserting his wife and family at Port Chalmers on the 4th ultimo. Offender is a Swede, a lumper, 33 years of age, 5 feet 7 inches high, stout firm build, fresh complexion, dark brown hair, clean shaved, generally lets his beard grow for about a week before shaving. He left Port Chalmers on the 4th ultimo, supposed for Lyttelton, or one of the northern ports, to seek employment as a lumper.

A warrant has been issued by the Lyttelton Bench

for the arrest of John Blackmore, charged with disobeying an order made by that Bench to provide for the support of his wife. Offender is a native of Tasmania, a blacksmith, 31 years of age, 5 feet 8 inches high, stout build, about 14 stone weight, fresh complexion, grey eyes, sandy beard whiskers and moustache, thick lips, pug nose, anchor on left hand. He worked about a year since at his trade in Dunedin, and went under the names of John Evans and Johnson. He will likely seek employment at an inland town.

Stolen on the 4th instant, from the person of Thomas Cassley, in the Railway Hotel, Tokomairiro, a large size hunting patent lever watch, No, 3228, capped and jewelled. T. Nutsford, Milton, maker. White dial, maker's name on dial, black figures, gold hands, value £10. Identifiable. Suspicion attached to William Mathew, a Scotchman, a carpenter, 40 years of age, 5 feet 10 inches high, stout build, large beard, whiskers, and moustache, wore dark tweed clothes, lace up boots, and drab felt hat.

Between 7 p.m. on the 27th and 7 a.m. on the 28th ultimo, the shop of Joseph Booth and Company at Oamaru, was burglariously entered, and four pairs of men's shoes, one piece of red and black tartan, about six pieces of Llama, blue, brown and

dark green colors; six crimean shirts; twelve pairs of socks with red tops; a brown silk umbrella; about eight pairs of men's light drab tweed trousers with black stripes, stolen therefrom. Value, £30. Identifiable.

Stolen on the 11th ultimo in the Octagon Hotel, Dunedin, from the person of Robert Harvey a silver lever hunting watch. Maker, John T. Coote, No. 254534. Value, £6 10s. Identifiable. A man of the following description who was in Harvey's company when he lost the watch suspected; about 23 years of age, 5 feet 9 or 10 inches high, medium build, no hair on face, wore dark clothes.

He is about 5 feet 2 inches high, medium build, wore dark clothes, small black moustache, good-looking, speaks English imperfectly, supposed to have a slight cut on the head, caused by falling against a window. Identifiable.

Heiley is about 35 years of age, 5 feet 1 inch high, medium build, fair complexion, fair hair turning grey, wore brown rib dress, black lace scarf, white hat and feather.

Inquests.

An inquest was held on the 2nd ultimo at the West Taieri Hotel, Outram, by James Fulton, Esquire, R.M. and Coroner, on the body of Henry Sutherland, a seaman and labourer, aged 20 years, who was drowned while bathing in the Taieri river at East Taieri on the 29th of December last. Verdict: Accidentally drowned.

An inquest was held on the 7th ultimo at Greenfield station, Tuapeka district, by E. H. Carew, Esquire, R.M. and Coroner, on the body of Daniel Campbell, a carpenter, aged 40 years, who was found dead in a hut there on that morning. Verdict: Died from natural causes.

An inquest was held on the 12th ultimo at the Ballarat Hotel, Arrowtown, by H. A. Stratford, Esquire, R.M. and Coroner, on the body of Ah Look, a miner, aged 33 years, who, when crossing the Matatapu Creek on the 8th ultimo, fell into the creek and was drowned. Verdict: Accidentally drowned.

An inquest was held on the 18th ultimo at the Waitaiki Bridge Hotel, Waitaiki, by T. W. Parker, Esquire, R.M. and Coroner, on the body of Jennie Verten, a theatrical performer, aged 20 years, who was drowned in the Waitaiki river on the day previous by the upsetting of an express in which she was crossing the river. Verdict: Accidentally drowned.

An inquest was held on the 15th ultimo at the Kent Hotel, Greytown, by James Fulton, Esquire, R.M. and Coroner, on the body of William Smith, a labourer, aged 26 years, who was killed by a fall of earth while at work in a ballast pit at Greytown on the day previous. Verdict: Accidentally killed.

An inquest was held on the 25th ultimo at the Hospital, Dunedin, by T. M. Hocken, Esqu;re, Coroner, on the body of Catherine Ryder, a prostitute, aged 40 years, who died there on the day previous from the effects of injuries sustained by being thrown down an embankment in Clark street, Dunedin, on the 14th ultimo by a man, name unknown. Verdict: Manslaughter against a man, name unknown.

An inquest was held on the 26th ultimo at the Hospital, Dunedin, by T. M. Hocken, Esquire, Coroner, on the body of James Amos Holmes, a pigdealer, aged 25 years, who was stabbed by John Walter in the left side with a knife at North East Valley, Dunedin, on the 24th ultimo, from the effects of which he died on the following day. Verdict: Manslaughter against John Walter. Walter has been arrested and committed for trial.

An inquest was held on the 1st instant at the Hospital, Dunedin, by T. M. Hocken, Esquire, Coroner, on the body of Charles L. Adams, a cordial manufacturer, aged 38 years, who died suddenly on the previous day in the Shamrock Hotel, Rattray street, Dunedin. Verdict: Died of fits appertaining to apoplexy.

An inquest was held on the 1st instant at Eichardt's Hotel, Queenstown, by R. Beetham, Esquire, R.M. and Coroner, on the body of Charles Murray, a miner, aged 53 years, who died on the previous day on Lake Wakatipu, while being conveyed from Moke Creek to Frankton Hospital. Verdict: Died from acute inflammation of the bowels.

Missing Friends.

Information is requested respecting the whereabouts of Harry Larkins, a witness in the case of Regina v. Walmer, charged with sodomy, committed in the Canterbury province. Larkins is about 28 years of age, 5 feet 7 or 8 inches high, medium build, sallow complexion, light hair, slight fair whiskers, beard and moustache, wore light tweed paget coat, moleskin trousers, light tweed cap or felt hat, carried a heavy swag—a new arrival. He crossed the Waitaki river from Canterbury into this province on

the 5th December last, at Gunnion's station, and will likely seek employment at a station or on a road party.

Information is requested respecting the whereabouts of John Quin, the principal witness and informant in the case of Regina v. Harry Pearce, committed for trial for stealing from the person at Dunedin. Quin is a native of Cork, Ireland, a laborer and shearer, 36 years of age, 5 feet 8 inches high, sandy hair, sandy whiskers, beard and moustache worn rather short, thin features, florid complexion, light blue eyes, large front teeth, described in the Otago Police Gazette, 1871, page 71, as John Roland, alias Quin, alias Kelly. He was employed at Merrie Creek Station, Balclutha division, for about three months, previous to the 30th November last. He left the Station after the shearing, and was heard of at Clinton on the 1st of December.

Information is requested respecting the whereabouts of Charles Hovenn, a carpenter's assistant, 15 years of age, not tall for his age, stout build, dark complexion, brown hair, dark blue eyes, wore dark tweed clothes, all of same material, lace-up boots, and cheese-cutter cap. He left his home at Dunedin on the 10th ultimo, and has not been heard of since.

MISSING FRIENDS.

Information is particularly requested of the present whereabouts of John McIntyre, who left Port Adelaide in the steamer Atijeh, on the 22nd August, 1874, under the name of John Mills, in company with a female. Description: A blacksmith, aged about 40 years, 5 feet 9 inches high, pale complexion, brown hair, lump under one eye. It is reported that he has been married to the woman with whom he left either in Melbourne or Sydney. The attention of the Police in the other Colonies is called to this case, as his wife and family are left destitute in Adelaide.

Information is requested respecting William Terry, native of London, a tailor, who left London in 1836 in the ship *Queen Adelaide* for some one of the Australian Colonies.

Information is requested respecting Mary Simmons $n\acute{e}e$ Faull, who, with her husband John Simmons, emigrated to some one of the Australian Colonies in 1848. Mary Simmons is a native of Polgooth, Cornwall; her husband, John Simmons, a native of Sticket, Cornwall, a practical miner. He was employed as schoolmaster on his arrival in the Colonies until the time of the Victorian gold diggings, to which place he went. When leaving England they had two children, Stephen and Lydia Simmons, who, if now alive, would be over 30 years of age. The attention of the Police in the neighbouring Colonies is called to these missing friends, as it is uncertain to which Colony they came.
