Felonies and Other Offences.

A warrant has been issued by the Invercargill Bench for the arrest of Duncan McFarlane, *alias* David Lorrell, *alias* Larrell, charged with bigamy at Auckland, on the 6th September, 1872.

Offender is a native of Ota., Argyleshire, Scotland, a shoemaker, 40 to 45 years of age, between 5 feet 10 inches and 6 feet high, stout, able frame, good looking, dark complexion, brown hair, clean shaved except goatee, served in the New South Wales Police Force for several years, and kept a stall in the Sydney Market ; he also kept a store in Maitland street, Dunedin, in 1863, and in 1866 or 1867 kept Mack's Hotel, Greymouth, West Coast, and in 1870 lived at Tauranga. He is known to James Kennedy, hotel-keeper, Melbourne (who kept the Robert Burns Hotel, in George street, Dunedin), to Constable Slattery, of Melbourne, to John Kennedy, of Carrington, to Webb and Booth, commission agents, Sussex street, Sydney, and to Elizabeth Norris, whom he married at Auckland in September, 1872, and who is supposed to be residing with her father, W. J. Norris, grocer, Forest Lodge Glebe, Sydney, N.S.W.

Offender left the Bluff on the 24th ultimo, by the steamer Claud Ramilton, for Melbourne, giving his name as Mr Larrell.

A warrant has been issued by the Dunedin Bench for the arrest of John Kenny, charged with deserting his wife and family, at Dunedin, on the 26th instant.

Offender is a native of Cork, Ireland, a laborer, 34 years of age, 5 feet 7 inches high, stout build, black hair, dark brown whiskers and moustache. He is supposed to be residing in the Tuapeka district. A warrant has been issued by the Invercargill Bench for the arrest of David Waddle, charged with indecently assaulting a Miss Shields, at Woodlands, on the 21st instant.

Offender is a Scotchman, a carpenter, 27 years of age, 5 feet $7\frac{1}{2}$ inches high, fair complexion, dark brown hair, light brown beard, whiskers and moustache, wore dark cloth coat, dark tweed trousers, cloth cap, and water-tight boots.

Warrants have been issued by the Oamaru Bench for the arrest of George White and John Buckley, charged with deserting from the hired service of the New Zealand Meat Preserving Company, at Kakanui, on the 1st instant.

White is about 17 years of age, 5 feet 8 or 9 inches high, fair hair, pale, sickly complexion, slightly pockpitted, slight build, wore broad brimmed black felt hat, and colonial tweed suit.

Buckley is an Englishman, about 20 years of age, 5 feet 3 inches high, square, thick-set build, fair hair, no whiskers or moustache, wore brown tweel sac coat, and light colored trousers. It is supposed they will endeavor to get employment on board a ship going to England.

Between 9 p.m. on the 17th and 6.3C a.m. on the 18th inst., the dwelling of McDonald and Doring, butchers, George street, Dunedin, was burgariously entered, and a common tin japanned cash-box, size 6 by 3 by 2 inches, containing a £10 note, 4 £1 notes, £2 in gold, £3 in silver, a cheque on the Bank of New Zealand, Dunedin, for £29 2s 6d, signed by Bartlett and Thomson, and a cheque on the same Bank for £25 16s 6d, signed by Driver, Stewart and Co. in McDonald and Doring's favor, an I.O.U. for £14, signed by David Kennward, an agreement between McDonald, Doring and Thomson, and a dishonored acceptance for £85 13s 10d, signed by J. C. Spence.

Inquests.

An inquest was held on the 28th ultimo at the Hospital, Lawrence, by Edward Herbert, Esq, J.P., on the body of John Ingram, a miner, aged 49 years, who died there suddenly on the day previous. Verdict— Died from disease of the heart.

An inquest was held on the 22nd ultimo at the Victoria Hotel, Naseby, by William Grummitt, Esq., J.P., on the body of Bridget Mongover, a servant, aged 25 years, who died at Naseby on the previous day from the effects of injuries sustained on the 20th ultimo by the capsizing of a dray on which she was sitting. Verdict—Accidentally killed.

An inquest was held on the 29th ultimo at the Mosgiel Hotel, Mosgiel, by T. M. Hocken, Esq., Coroner, on the body of Charles Forrester, a farmer, ⁹ged 47 years, who was drowned at East Taieri on the day previous when crossing the Silver Stream. Verdict—Accidentally drowned.

An inquest was held on the 30th ultimo at the Hospital, Switzers, by J. W. Wood, Esq., R.M. and Coroner, on the body of Perry Adams, a miner, aged 60 years, who died there on the day previous. Verdict—Died from natural causes.

An inquest was held on the 3rd instant at the Globe Hotel, Princes street, Dunedin, by T. M. Hocken, Esq., Coroner, on the body of John Reid, a blacksmith, aged 40 years, who fell dead on that day while at work in Reid and Gray's foundry, Princes street, Dunedin. Verdict—Died of disease of the heart.

An inquest was held on the 4th instant at the Provincial Hotel, Port Chalmers, by David O'Donoghue, Esq., Coroner, on the body of Isaac Crisp, a sailor, aged 27 years, who, on the day previous, fell off the railway pier at Port Chalmers into the harbor and was drowned. Verdict—Accidentally drowned.

An inquest was held on the 6th instant at the Geelong Hotel, Alexandra, by W. L. Simpson, Esq., R.M. and Coroner, on the body of Edward Thompson, a laborer, aged 27 years, who was killed at Alexandra on the day previous by a stone wall falling upon him. Verdict—Accidentally killed.

An inquest was held on the 8th instant at the residence of James Crane, Taieri Beach, by J. P. Maitland, Esq., Coroner, on the body of Tui Tu, a Maori, aged 80 years, who was burned to death on the 5th instant at the Taieri Beach by the hut in which he was living catching fire. Verdict—Accidentally burned to death.

An inquest was held on the 11th instant at the Bendigo Hotel, Blacks, by J. D. Nevin, Esq., J.P., on the body of a man known as "Tom," who was found dead in his bed at the residence of William Faulkener, Ruggedy Ridge, on the morning of the 7th instant. Verdict—Died from disease of the heart.

Deceased, who was unknown in the district, was about 45 years of age, 5 feet 7 inches high, stout build, black hair, beard, whiskers, and moustache. He said he was an Englishman, and by trade a shoemaker.

An inquest was held on the 12th instant at the Reliance Hotel, Otakia, by T. M. Hocken, Esquire, Coroner, on the body of Isaac Cox, a labourer, aged 40 years, who died there on the 9th instant from the effects of injuries sustained two days previously by accidently falling down stairs in the hotel. Verdict— Died from effusion of blood on the brain, caused by accidentally falling down a flight of stairs.

An inquest was held on the 13th instant at the Ballarat Hotel, Arrowtown, by H. A. Stratford, Esq, R.M. and Coroner, on the body of Cheong Ah Sing, a miner, aged 30 years, who was on the day previous found dead in a gully at the Eight-mile, Arrow River. Verdict—Found dead.

Extract from Queensland Police Gaette.

From Gazette 6th August, 1873. Robberies under Arms.

Three men, names not given, but who can be identified, are charged on warrants issued by the Blackall Bench with having on the 18th June, 1873, when under arms, stolen from Malvern Hill station, Blackall, the following property of A. R. Brown and others, viz., one bay gelding, E near shoulder; one black gelding, either 474 or $H_{\Lambda}H$ on Shoulder; three Terry's breach loading rifles; one large Colt's and two single-trigger Tranter's revolvers; one new double-sewn bridle, red forehead band, two old bridles, a breast-plate and new crapper, a German silver lever watch, some bulletmoulds, about £10 in cheques, one for £1 5s 6d, J. Tweed on Bank of New South Wales, one for £1 1s, ON Rome Bros., Northampton Downs, one for £1 1s, W. Crombie. Offenders are described as follows :--1st. About 5 feet 10 inches high, straight and slight build, about 33 years, dark brown hair, prominent eyebrows, short nose, thick, short, dark moustache and beard, little or no whiskers, sallow complexion, very bad expression, wore a new light-colored wideawake hat, with black band round it, a light tweed coat, leggings, rode a fine-looking bay horse, rattish tail, off fore foot white. 2nd. About 5 feet 9 inches high, 25 years of age, slight build, light brown hair, long face, short stubby hair on face, not much of it, shows his teeth slightly, evidently a native, dressed in an old felt hat, pepper and salt coat and trousers, elastic-side boots. This offender took a pair of Napoleon boots out of the store. 3rd. About 5 feet 8 or 9 inches high, 20 years of age, slight slight build, very light hair and complexion, a little light down on his face, long thin features, blue eyes; dressed in cabbage-tree hat, white handkerchief drawn through a "quandong" stone, blue coat, brown tweed trousers, elastic side boots; rode a grey mare. The above described offenders were armed with revolvers, and stuck up all the people on the station. They are

believed to be identical with the brothers Faulkner from Bathurst, and one Sweeney who was convicted of horse-stealing at Wallgett about six years ago.

Bob Barnfield, James Falconer and John Falconer, alias James Thompson and John Thompson, are charged on warrant, issued by the Cunnamulla Bench, with having on the 22nd June, 1873, when under arms, stolen from James Tyson, at Tinneburra station, in the Warrego district, two horses (not described) and some rations, and stuck up the people on the station ; also with having fired on the police on the Bullo, when in hot pursuit. Offenders are described as follows : 1st. Barnfield, about 30 years of age, 5 feet 10 inches high, medium build, heavy eyebrows, sunken eyes, dark sallow complexion, rather pale face, heavy beard on chin, scarcely any whiskers, Yankee appearance, tweed coat and felt hat. 2nd. James Falconer, about 23 or 24 years of age, 5 feet 8 inches high, slight build, young beard, grey tweed coat and trousers, elastic side boots; rode dark grey horse. 3rd. Jack Falconer, about 20 years of age, about 5 feet 8 inches high, slight build, fair hair, no hair on face; wore blue coat, light trousers, cabbage-tree hat, wore handkerchief ran through quandong stone (vide former item). These offenders are believed to have been the bushrangers who robbed the Malvern Hill station.
