NOTICES OF MOTION.

Re Alterations and Additions to Constitution.

That Rule I be amended to read -"The name of the Association shall be the 'Women's Christian Temperance Union of New Zealand, Incorporated,' and is hereinalter re-ferred to as 'The Union.''

That Article II. be amended to read-"The objects of the Union are : (1) The furtherance of the cause of Temperance throughout New Zealand. (2) The total abolition of the alcohoi and opium traffic from New Zealand. (3) The promotion of social reforms and of Christian work.'

That Article V. have the following added to it :- "Notice of the Convention shall be given by the President by advertisement in the official organ of the Union."

That Article VI. have the following words inserted after the word "ballot" :- "Voting on other matters shall be conducted by show of hands, unless a ballot is demanded by any member.

That Article VII. shall have the following words inserted after the words "World's Fund" : - "The funds of the Union shall be under the control of the President, Recording Secretary, and Treasurer, who shall place such funds on cur-

rent account or fixed deposit in a Bank carrying on business in New Zealand."

That the following New Rules be added to our Constitution :--

If Any Society whose objects conform in general to those of this Union, as set out in Article II. hereof, and which is desirous of being admitted to membership of the Union, may be so admitted upon application in writing signed by the President and Secretary of that Society, and addressed to the Secretary of the Union, and upon payment of the sum fixed from year to year as the amount of the membership fee. Provided that every such application shall be authorised by a resolution duly passed at a regular meeting of the Society making the application.

2. Any officer of the Union, District President or duly appointed Organising Agent may form new Societies as occasion demands, and such Societies may become affiliated to the Union on complying with the terms of Rule I above.

3. Any affiliated Society wishing to withdraw from the Union may do so by sending to the Union Secretary notice in writing of its intention to withdraw, provided that all moneys due by such Society to the Union have been previously paid.

4. The common seal of the Union shall be under the control of the Recording Secretary.
