#### A CORRECTION.

In the May issue of the "White Ribbon" there appeared a statement that out of the total of £8.116.894 of the New Zealand Drink Bill £3,265,049 goes out of the country. This is a miscalculation, and we would ask our readers to note the correct position, which is that the imports of all kinds of intoxicating liquor during the year 1929 had an estimated total invoice value of £679,344. This represents the amount of money that has to go overseas to pay for these liquors.

It hay be mentioned that the value as stated in the Abstract of Statistics for Customs purposes is £754,826. But this value is the invoice price, plus 10 per cent. added by the Customs before the duty is levied. This method applies to all things imported. For example, if boots to the invoice value of £100 are imported, the Customs Department adds 10 per cent., and the importer has to pay Customs duty on f110. The consequence is that when trying to arrive at the amount of money sent overseas for liquor, we have to deduct 10 per cent. from the value stated in the Abstract of Statistics, and, as above-mentioned for the year 1929, this gives us the figure of £679,344,

#### BIBLE IN SCHOOLS.

It is over half a century since the Bible was excluded from our Primary Schools. It has never been banished from Secondary Schools. Nelson refused to banish the Bible, and instituted its system of Bible teaching in school hours by utilising half an hour left free. The Act says schools must be open for secular instruction 24 hours a week. Most schools are open 25 hours weekly, and the Nelson schools took advantage of this extra hour to provide half an hour's Bible teaching weekly.

When the Bible was banished from our schools, we had parents and teachers who had been educated under the old system and who knew their Bibles. But with the lapse of years, these have passed on, and we have teachers and parents educated on the "No Bible" system. And it has not improved our social life or our moral condition. Bible sets the standard of conduct high, and it tells the child of the loving Friend Jesus, who will help him to live up to that high standard. It is not much use appealing to the child to be honest and truthful because "Honesty is the best policy." But every true teacher knows how readily the child responds to the appeal to be honest and pure and true because Jesus wants them to be so. Love is the fulfilling of the law, and the Bible teaches the personal devotion to a Leader who is worthy of our highest and best.

The Bible in Schools Bill, to be introduced this session, provides for the Bible to be read in our schools. It should satisfy all reasonable people. It provides for a conscience clause for both teachers and pupils. It also provides that schools in which the Nelson system is working well may continue to teach under that system. The Bill authorises teachers to give religious instruction, with a conscience clause for both pupils and teachers.

Our Unions will help in every way to give the Bible the place it should have in our system of education.
