

There is a RISING TIDE of public sentiment against everything connected with the Liquor Traffic. One indication of this can be seen in the number of Bills being introduced in the Legislative Assemblies of the United States. Between 1954-55, approximately 1,654 Bills were introduced, calling for restrictions, controls, and bans on the sale, serving, and consumption of alcoholic beverages. The DRY forces of the country are taking the initiative and putting the liquor interests on the defensive.

From *Tulsa*, *Oklahoma*, comes word that radio station KOME has left the Mutual Broadcasting System, rather than advertise BEER. The network insisted on the station carrying beer advertising.

There is also a steady increase in the number of newspapers and magazines that refuse to accept liquor advertising. The liquor interests are keenly aware of this fact.

The Kefauver Crime Commission in its nation-wide investigation put a stigma on almost everything that was connected with the manufacture, distribution, sale, and consumption of alcoholic beverages. The Commission made it evident that the CRIMINAL ELEMENTS were tied in with the LIQUOR INTERESTS.

All through the *MIDDLE EAST* and *SOUTHERN ASIAN* countries, alcoholic beverages are looked upon as a curse and a necessary evil, when dealing with Westerners. No good Hindu, no outstanding Moslem, will drink.

Iran has declared nation-wide prohibition.

The King of Saudi Arabia has banned alcoholic beverages from his land.

In India, no man may run for public office, if it is known that he is a drinker. The constitution of India calls for a gradual introduction of prohibition. India, with its deep religious convictions, its cultural and philosophical backgrounds, its idealistic outlook, may yet set the pace, and lead the world in so far as the banning of alcoholic liquors is concerned.

This year, New Zealand will be having a Dominion-wide referendum on the Liquor Question All who have a vital interest in the welfare of this country, will have the opportunity of declaring themselves with this RISING TIDE against beverage alcohol, by registering their vote to outlaw an evil that continues more and more to increase accidents, suffering, death, and crime.

THE YOUNG ABSTAINERS' LEAGUE ITS COMMENCEMENT AND HOW YOU CAN HELP

To all who desire to see progress within the Temperance Cause, particularly among the young folk of our country, the formation of Young Abstainers' League in New Zealand should present an immediate challenge. How can W.C.T.U. members assist? By understanding how the League works, and in order to do this, a letter from one of the organisers in Palmerston North is here quoted, together with the leaflet setting forth further details of the organisation. Mr. A. MacClure, of the Post Office Staff of Nelson, but until recently living in Palmerston North, writes:

'The Young Abstainers' League was originally introduced in an effort to replace the work previously undertaken by Bands of Hope. It has advantage over Band of Hope work, in that it can be incorporated into existing organisations in a Church or Sunday School, without affecting them, for it means no extra meetings, etc. It is 'an' organisation within an organisation' and so can reach a greater number of young people. The Temperance education and teaching are achieved through the quarterly leaflet, 'The Young Ab-tainer', and through films and the distribution of other temperance literature at the half-yearly rallies.

"The first League was formed in Palmerston North in July of last year, and so far 13 Leagues are now in operation and more than 400 pledges distributed. Any interested person or organisation can undertake the responsibility of organising Leagues in their town or district. Supplies of pledge cards and badges are obtainable from Mr. W. Lyon, 490 Church Street, Palmerston North. Several W.C.T.U. branches have already written for information, and the Palmerston North members have been a great help at our first Rally last February.

What Is The Y.A.L.?

It is a League of young people, who have signed the Total Abstinence Pledge for the sake of their own spiritual and physical well-being-and for the sake of helping others, who may not be as strong as they are.

Its Aim

To promote Total Abstinence from alcoholic liquor as a way of life.

The Pledge

"In order that I may attain to the highest good in life, and that I may be at my best for the service of God and my fellow men, I promise, by God's Grace, to abstain from all alcoholic drinks. I further promise that I will do all that within me lies to advance the cause of Total Abstinence."

Who May Join?

Anyone over the age of eight years, who, understanding the implications and responsibility of such an undertaking, is prepared to sign this pledge. The parents' consent is required for those

signing who are aged 12 or under.

The membership fee is 1/- per year. Distinctive badges are available at a cost of 6d. The Quarterly Leaflet is free to all members of the Y.A. League

How To Form A League

1. Write to the Secretary, Mr. W. Lyon, 490 Church Street, Palmerston North, for supply of Pledge Cards, Badges, and Leaflets.

2. Appoint a Leader or Secretary to be responsible for the League's successful operation.

Make the organisation of the League as widely known as possible.

MISS C. E. KIRK, J.P. A Temperance Stalwart Passes



Miss C. E. Kirk of Wadestown, Wellington, passed from this life to the Glory Land on Sunday, 19th May. We thank God for her life of valiant service, for she was truly a woman of God, and we rejoice that suffering is over, and that she has entered into the joy of the Lord, whom she loved. She followed her Master, in devoting her long life to the service of God, and of her fellow beings. How keen she was to save men and women, boys and girls from the ravages of beverage alcohol! Scripture Reading: Ephesians 6:10-18. W.R. Hymnal No. 25.

The power of influence is a responsibility no one can escape. Always, whether we realise it or not, our lives are affecting others. The frowns, the sneers, the harsh or careless words, and passionate outbursts continue winging their way through time, long after we have forgotten them. Likewise too, the little acts of kindness and courtesy, the love we show, the sympathy we express, the stand we take on moral issues, all send their ripples of influence on and on, ever wider and wider as the days go by.

So it is that whether we will it or not, we are always leading others in some direction, and through them, still others. Once the influence has started, we cannot control its spread. Hence, then, if our lives are true and good, this influence is a blessing to others and will continue on through them. Please read this at Union Meetings

Cabinet Ministers have replied to resolutions as follows:

1. Re Postage Rates. The Hon. Mr. Shand, Postmaster General, writes that the Government would like to give preferential treatment to some organisations, but is unable to do so. Postage rates on second class matter were increased to 2d., as the ½d. increase was no more than sufficient to cover additional transport and delivery expenses over recent years.

2. Re cartons and beer containers. The Hon. Mr. Halstead, Minister of Indus^{*}ries and Commerce, replied that, as beer is bottled under pressure, it requires special containers, such as glass bottles. No legislation compels manufacturers to packfood and drink in any special container. Local body by-laws forbid depositing of broken bottles and litter in public places. He suggests that publicity given to this offence, and to any prosecution, should be effective in providing a strong deterrent.

(Note: The Minister is not clear as to what steps should be taken to give such publicity. Consequently his answer is not what we would regard as satisfactory.)

3. Re Liquor on Aircraft. The Hon. Mr. Shand, Minister in Charge of Civil Aviation, writes that he has asked the Air Secretary to request N.Z. Airways Corporation and TEAL to comment on this remit. Meantime, he points out that Regulation 49 of the Civil Aviation regulations gives pilots power to disembark passengers who misconduct themselves. Regulation 56 provides that, neither crew, members, or passengers should enter aircraft in a state of intoxication.

(Note: These two regulations answer the second half of our remit, but we await the Minister's further comment on the first half of this remit, which asks that the sale or supply of liquor be discontinued on aircraft.)

4. (a) Re Sale of liquor to Minors. The Hon. Mr. Marshall, Minister of Justice, considers that the present penalties are in proportion to those provided for similar breaches of the Licensing Laws. He thinks it undesirable to increase the penalties, except as part of a general review of the Licensing Act. This will be undertaken at an

opportune time. (Note: We hope that the opportune time will be soon, as it is well overdue. The mischief arising from the sale of liquor to minors is very great, and many hotel-keepers appear to have little conscience on this matter.)

(b) **Re use of bars for drinking after hours.** The Minister states that the Government is giving this matter careful consideration and will take any appropriate and practicable steps to assist the Police in their task of reducing the incidence of this offence.

(Note: Responsible Police officers have stated that the present uncertainty of interpretation of the law makes it very difficult to arrest people who are wrongfully on licensed premises after hours. We hope that the Government will clarify the law on this matter.)

5. Re Gambling. The Hon. S. W. Smith, Minister of Internal Affairs, has replied that the Government will give earnest attention to our remits. As he is to make a more detailed reply, this will appear later in the "White Ribbon".

We were disturbed by reported statements by the **Rt. Hon. W. Nash, Leader of the Opposition**, on the matter of policy of his party concerning gambling, should his party become the Government after next election. As I felt he had possibly been incorrectly reported, I wrote to him, and an interview was kindly granted. He assured me that his party would not extend the hours of sale of liquor in hotel bars without a referendum. He said that he, personally, would do all he could to see that there was no increase in drinking and gambling, but would not commit himself over sales of liquor in restaurants and in grocery stores.

From the Hon. Mr. Eyre, Minister of Police: "The laws about the sale of liquor in N.Z. are complex, and not so easily enforced as at first sight may be supposed. I think it true to say that there is no single law in this country, which is so costly in time and man-yower to enforce, as the liquor laws, nor is there are Police Force in any Englishspeaking country, which has to devote so much

Candid Comments By Citizen

Last year, the work of Mr. P. J. Campbell (Pita Karima), who was appointed the first warden in Wellington for the Maori people under the Maori Social, Economic, and Advancement Act, was reported upon in this Column. A total abstainer, and the Wellington leader of the Pioneer Total Abstinence Society of the Roman Catholic Church. We regret to say that he was killed recently in an accident, but we hope that other Maoris will take up his work for Temperance for both Maori and Pakeha.

The administrator of Natal, Mr. Shepstone, has stated recently, that 90,000 alcoholics are costing South Africa between £30 million and £50 million a year. Speaking at the recent conference of the N.Z. Hospital Board's Association, a doctor estimated the number of alcoholics in N.Z. as between 10,000 and 15,000, and that 10 other people, family, employer, friends, were affected by each alcoholic. The Association called on the Health Department to form and implement a long term policy for the treatment of alcoholics. He suggested that a medical man be sent overseas to study

treatment methods. The N.Z. Associated Chambers of Commerce are pressing hard for restaurant drinking. Of course, extra facilities for sale will create more alcoholics. Consumption in N.Z. is steadily rising for beer and stout and is now at 22 gallons per head, compared with 24¹/₂ gallons in Australia and 18 gallons in Britain.

Speaking to the 38th Annual meeting of the American College of Physicians, Dr. Robert Rark said recently that a cheap and ready supply of liquor was a major factor influencing the extent of alcoholism and ailments associated with it. The N.Z. Hospital Boards' Association would do better to work for prevention rather than for cure. It should ask the Health Department to advertise the benefits of total abstinence and ask for the prohibition of the large liquor advertisements sponsored by the Brewers' Association, inviting people to drink beer on ALL occasions.

It is good to report that the N.Z. Associated Churches of Christ at their conference, made a strong plea against liquor in restaurants and evening hours of sale. NOW is the time for prayer and work against this agent of the Evil one. May all our Churches be right on the job.

We are also appreciative of contributions from others during the year particularly mentioning Herbert Hoare of Queensland and for helpful information and articles from Overseas' "Exchanges". I am pleased to know that many of these "Exchange" magazines make use of our "White Ribbon", and we hope that they will continue to do so.

To our Union News reporters, and Convention reporters. I express my thanks for their regular and concise reports. May I again sincerely thank all those who have sent greetings and letters during the year. Your messages have been appreciated.

The Beacon: I have again enjoyed the preparation of our teenage paper, and have been very pleased to receive many encouraging letters from young readers. It is gratifying to find that so many of the B.C. age group find an interest in the "Beacon". Writers particularly like the stories and the news of athletes and others who figure in World News, and Miss J. Campbell's Devotional Corner. We would thank Miss Campbell for this valuable spiritual column, so willingly contributed. "W.R." Supplement for Boys and Girls: This children's little paper is prepared for children ranging in age from those first able to read, to the end of primary school life. With so small a space available, it is most difficult to cater for this age range. The pictures for colouring are provided for use by any age, but naturally the colouring work should be in keeping with the child's class at school. Some very fine work was sent in from Northland District for their Annual Competition, and their prizes numbered 27 books and many cards. The Colouring Competition is designed to create interest, so that the whole Supplement will find an entrance into many homes.

Business Manager's Annual Report

In presenting a report of the year's working to 31st December 1956, I am pleased to state that there have been increases in the number of "White Ribbons" posted out, as well as in the number of Beacons and Boys and Girls' Supplements. The following is the distribution of the 115 new subscribers:

North Island:

Northland 20, Auckland 12, South Auckland 8, Wanganui 2, Manawatu 5, Hawke's Bay 1, Wellington 8, a total of 56.

South Island:

Marlborough 2, Nelson 9, North Canterbury 9, South Canterbury 7, Otago 29, Southland 3, a total of 59.

The Union with the largest number of subscribers is Dunedin Central with 81, Riccarton comes next with 57, and Wellington Union 55. Dunedin Central gained the most new subscribers, 19, while Whangarei followed with 12.

On a per entage basis with a Union membership of under 20, **Balclutha** gained the highest, 7 new subscribers, or 40 per cent.

The Beacon: Average monthly number sent out is 1,075, and Boys' and Girls' Supplements, approximately 7,150.

If we seek to do our part in this work for Him, then God will surely bless our labours. time to its liquor laws as does the N.Z. Police Force. Year by year, as the statistics show, more publicans and their employees are brought before the Courts, but yet more valid defences than ever are being raised. Your Union should understand that it is not because of lack of interest on the part of the Police Force that there are so many breaches of the law....

"The Police Force, within the limits of its personnel and demands upon it, to prevent crime in its manifold aspects, is doing all that can be reasonably expected of the Force to control the illegal sale of liquor."

(Note: Unions should note especially the words I have emphasised which show the waste of time and energy caused by the consumption of liquor.)

From the Hon. J. A. Hanan, Minister of Health, who states that his Department sees some merit in our remit asking for labelling wines with their alcoholic content, but also sees great difficulty in bringing it about. Trade practice tends to refer to the proportion of alcohol in terms of proof spirit, but a lot of wine is imported from countries where a variety of labelling requirements apply. It would be difficult to make these overseas' bottlers comply with N.Z. requirements as often the N.Z. market is small. Although there are no general requirements for the maximum and minimum content of alcohol in wires, the most common varieties are required to conform to generally accepted standards. Some particular requirements as to composition are set out in the Food and Drug Regulations of 1946.

From Assistant-Secretary, N.Z. Road Safety Council, "The name of the N.Z. Road Safety Council appears on the latest Brewers' Association advertisement owing to a misunderstanding, as it was understood that they would not use the name of the Road Safety Council after the slogan on their advertisement. Although there does not seem any likelihood, that, in its present form, the reference to the N.Z. Road Safety Council, would give rise to any impression that the Council sponsored the Brewers' Association advertisement, the Association will be discontinuing this reference.

"However, the Brewers' Association will continue to support the Road Safety Council's Campaign by quoting appropriate slogans from the Road Code. The new series of advertisements, in which the Road Code will be quoted will commence about the end of the month

The Licensing Control Commission's report shows concern over the number of hotels which are interested only in sales of liquor and not in providing accommodation. Its levy-rebate suggestion deserves careful consideration by the Government. We certainly do not favour the alternative to the levy-rebate, namely, the removal of the limitation of publican's licenses and the suggestion of allowing dancing and entertainment on licensed premises. Unions should oppose these ideas with all their might. Chartered Clubs should not be exempt from taxation on their sales of liquor.
